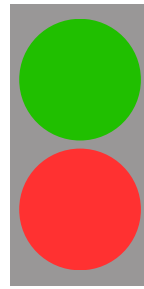

1- DIVIDEND BASE ROI BONUS INCOME .

1% Daily Dividend on every Investor`s Investment. For 300 Days. Starts from the date of investments.

1- Every investor should be eligible for this dividend, from the day of investment in the company`s investment plan .

2- Investor can withdraw his/her dividend amount on Daily Basis.

3- Before withdraw dividend amount, every investor shall be placed two direct junior investors, in his/her left and right downline. Its mandatory rule for dividend withdraw.

4- Daily Dividend withdraw capping amount limit is equal to amount of investment on that particular account. Means Daily capping limit is equal to ID VALUE of an account. An investor can improve his/her Capping limit with top up of an Investment amount.

2 - BINARY PAIRS 1 : 1 MATCHING BONUS INCOME .

10 % On every matching pair having ratio 1:1 Joining of an Investor .

1-Every investor can earn 5% one time referral bonus on every new direct joining of new investor .

2- Terms- Level 1- 2 Direct Investors (Downline -left & right leg each 1 is mandatory.)

3 - BINARY MATCHING BONUS INCOME .

0.5 % On every matching pair having ratio 1:1.

2-Every investor shall be placed two direct junior investors, in his/her left and right downline, its mandatory rule for Binary matching bonus.

4 - TEAM PERFORMANCE BONUS INCOME .
